

Terms & Conditions "HUSQVARNA Perfect Green Team" Cashback promotion

Husqvarna UK, Hans-Lorenser-Straße 40, 89079 Ulm (hereinafter: "Husqvarna") will reimburse eligible trimmer purchased under the conditions defined in these Terms and Conditions of participation (as long as stocks last) during the promotional period from 22.04.2024 to 26.07.2024 (hereinafter: "Promotion Period") from an authorized dealer (hereinafter: No. 3.). The reimbursement will be determined by the amount stated on the receipt of the purchase price of the promotional products without exceeding £329 (hereinafter: "cash back"). The transfer of the cash back is paid exclusively within the SEPA area.

1. Eligibility

Private end customers (private/natural persons) living on the UK territory who have reached the age of 18 at the time of purchase or enterprise settled in UK are eligible to participate in the promotion.

In addition, Husqvarna reserves the right to exclude persons from participation who can be proven to have committed intentional or negligent misuse in connection with the campaign. They are not entitled to the cash back. This is particularly the case if a person provides incorrect or misleading information to Husqvarna. In this case, all claims with regard to the " HUSQVARNA Perfect Green Team " cash back **promotion are forfeited**. In this case, Husqvarna expressly reserves the right to take further legal action.

2. Promotional Products and Promotion Period (IMPORTANT)

Husqvarna will grant the cash back bonus to the persons entitled to participate in accordance with this promotion, provided that they have purchased simultaneously one of the below specified combinations of Automower models and a battery trimmer kit as specified in Table 1 as new at an authorized dealer during the campaign period. The cash back reward will only be granted once per household or per enterprise and/or per bank account, only one reimbursement per purchase receipt.

IMPORTANT NOTE:

The PNCs listed in [Table 1](#) are country-specific numbers. Eligible persons who purchase a product and wish to participate in the promotion are responsible for ensuring that the **product they purchase has a PNC code that matches the PNC code of the promotional products listed** in [Table 1](#). The PNC code can always be found on the **product packaging**.

Authorized dealers (hereinafter defined in [Section 3](#)) may provide information on the PNC code of the respective products. Persons eligible to participate are advised to clarify the correspondence of the PNC of the products they have chosen with that unique combination of the promotional products listed above with the authorized retailer before concluding the purchase contract.

Identical products with a different PNC are excluded from the “HUSQVARNA Perfect Green Team” Cashback promotion.

3. Approved Dealers

The cashback refund will only be granted if the eligible person purchases one of the pre-defined combination of promotional products as defined in [Table 1](#) from an authorized dealer during the promotion period.

All registered Husqvarna dealers on the UK territory and the Husqvarna UK website (husqvarna.co.uk) are approved dealers for this promotion.

In addition, the reward is not granted for products purchased through dealers outside UK territory or other websites than those of UK Husqvarna dealers or Husqvarna.co.uk.

4. Claiming the Cashback

Each eligible person must register to claim the cashback reward and provide the following evidence (hereinafter: "Eligibility Requirements"):

- (1) The person entitled to participate must register at the latest the 10.08.2024 under <https://husqvarna-perfectgreenteam.uk> with complete and accurate data (surname, first name, postal address incl street name, number, city and postal code, country, e-mail address, bank account details). If the data provided is incorrect, Husqvarna is not obliged to determine the correct data. The disadvantages resulting from the provision of incorrect data are at the expense of the person entitled to participate.
- (2) In the course of registration, the person entitled to participate shall provide Husqvarna with proof of the purchase of the promotional product combination(s) from an approved dealer during the campaign period by uploading a complete and legible receipt of purchase or an invoice from an approved retailer for the purchased promotional product combination(s) under <https://husqvarna-perfectgreenteam.uk>. Purchase/cash receipts or complete invoices from an approved dealer can be uploaded until 10.08.24 at the latest for participation. These must show the purchase of all promotional product combination(s) claimed by the person entitled to participate. Only purchase/cash receipts or complete invoices will be accepted as proof. Delivery notes, order confirmations, receipts, etc. will not be accepted. Only one receipt or invoice can be uploaded per registration.
- (3) Furthermore, information about the *PNC code/s* by *uploading an image file* of the barcode and specify the date of purchase of the promotional product combination(s) in the input field provided under <https://husqvarna-perfectgreenteam.uk> are required.

The evidence of eligibility requirements described in points 1-3 above can only be submitted to <https://husqvarna-perfectgreenteam.uk>. Documents sent by post, fax or e-mail will not be considered for the promotion and cannot be returned.

There is no entitlement to the cash back if the above-mentioned eligibility requirements are not met. This includes cases where periods defined in these Terms and Conditions are not respected (for example, if the purchase did not take place or did not take place in full within the period from 22.04.2024 to 26.07.2024 or if no promotional product combination was not purchased during the campaign period).

The " HUSQVARNA Perfect Green Team" Cashback promotion cannot be combined with other promotions and loyalty promotions that include the listed promotional products (this also includes promotions and loyalty campaigns that are not organized by Husqvarna UK).

5. Verification and payment of the cash back

Within 14 days of receipt of the proof of eligibility requirements in accordance with Section 4 above, Husqvarna will check whether the "eligibility requirements" set out in these Terms and Conditions of Participation have been met. If this is the case, the cash back reward will be paid to the account specified by the eligible person in British Pounds by UK standard bank transfer. In the event of errors in the bank details provided by the person authorised to participate, there is no entitlement to a new transfer. The refund may not be paid out in cash or by any other means, as well as to an account outside the UK banking area.

Bank transfer will be provided between 6 to 8 weeks following compliant treatment.

The cash back bonus can only be transferred if the right of withdrawal/return has not already been exercised vis à vis the dealer with regard to the promotional product combination registered for this purpose.

In the event of the return of one of the promotional product or the product combination and repayment of the purchase price, the cash back amount paid out for the specific promotional product combination must also be refunded to Husqvarna. In this regard, Husqvarna expressly reserves the right to enforce claims by legal means.

6. Explicit reservation of revocation

HUSQVARNA expressly reserves the right to revoke the " HUSQVARNA Perfect Green Team" Cashback promotion at any time by public announcement.

7. Claim

Complaints regarding the operation sent after 10/09/2024 will no longer be processed.

8. Notes on data protection

We would like to inform you accordingly about the handling of your personal data provided in the context of the promotion in accordance with Art. 13 of the General Data Protection Regulation (GDPR).

2. The legal basis for the processing of your personal data is Art. 6 (1) (b) GDPR. The purpose of data processing is exclusively the execution of the campaign. As part of the promotion, the

following personal data will be collected from you: e-mail address, surname, first name, postal address, country, account holder details, Sort code and account number and the indication that you are over 18 years of age (mandatory information). For further details and supplemental terms on how to conduct such promotions, please refer to the "(S) Sweepstakes" section of our Privacy Policy.

3. Access to the data is only granted to employees of Husqvarna UK from the marketing department as well as to processors used to carry out the campaign, who need it to complete the task. In addition, the data will only be passed on to third parties insofar as this is necessary in the context of the processing of the campaign or is required by law.
4. Your data will be kept for the campaign period and then deleted 1 year after it ended (therefore 1 year after the claim date settled the 10.09.2024) if there are no statutory retention provisions to the contrary.

9. General Liability

- (1) In the event of intent and gross negligence – regardless of the legal basis – Husqvarna is liable in accordance with the statutory provisions.
- (2) In the event of simple negligence, Husqvarna shall only be liable for damages resulting from the breach of an essential contractual obligation, i.e. only in the event of a breach of such an obligation, the fulfilment of which is essential for the proper execution of the contract in the first place and on the observance of which the customer regularly trusts and may rely. In this case, however, the amount of liability is limited to the damage foreseeable at the time of conclusion of the contract and typical of the contract.
- (3) The personal liability of Husqvarna's legal representatives and vicarious agents for damages caused by their simple negligence is also limited to the extent described in Section 8 (2).
- (4) Husqvarna's liability in the event of fraudulent concealment of a defect, the assumption of a quality guarantee or a procurement risk and in accordance with the Product Liability Act remains unaffected. In addition, the limitations of liability in sections 8 (2) and 8 (3) do not apply in the event of injury to life, limb or health.

10. Limitation of Liability for Data Loss

HUSQVARNA shall not be liable for loss of data due to technical reasons in the context of data transmission after entry under <https://husqvarna-perfectgreenteam.uk>, unless the loss of data is due to a grossly negligent or intentional breach of duty by Husqvarna, a legal representative or vicarious agent of Husqvarna.
