**Composition comments** Mineral oil with additives. The mineral oils in the product contain <3% DMSO extract (IP 346).

## SECTION 4: First aid measures

### 4.1. Description of first aid measures

<b>Inhalation</b>	Move to fresh air. Call a physician if symptoms develop or persist.

**4.2. Most important symptoms and effects, both acute and delayed** Exposure may cause temporary irritation, redness, or discomfort.

**4.3. Indication of any immediate medical attention and special treatment needed** Provide general supportive measures and treat symptomatically. Droplets of the product aspirated into the lungs through ingestion or vomiting may cause a serious chemical pneumonia. Symptoms may be delayed. HIGH PRESSURE SKIN INJECTION: Physician must be familiar with local procedures for treatment of this type of wound; incision, irrigation, removal of all necrotic tissue and open wound dressing.

## SECTION 5: Firefighting measures

## SECTION 6: Accidental release measures

### 6.1. Personal precautions, protective equipment and emergency procedures

Avoid contact with skin and eyes. Wear protective clothing as described in section 8 of this safety data sheet. Keep unnecessary personnel away.

### 6.3. Methods and material for containment and cleaning up

Remove sources of ignition. The product is immiscible with water and will spread on the water surface. Following product recovery, flush area with water. Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible.

Large Spills: Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Wash area with soap and water.

Small Spills: Absorb spillage with non-combustible, absorbent material. Clean surface thoroughly to remove residual contamination.

Never return spills to original containers for re-use.

### 7.1. Precautions for safe handling

Use only in well-ventilated areas. Avoid inhalation of oil mist and contact with skin and eyes. Wear protective clothing as described in Section 8 of this safety data sheet. Wash contaminated clothing before reuse. Do not eat, drink or smoke when using the product. Be aware of potential for surfaces to become slippery. Avoid prolonged exposure. Do not cut, weld, solder, drill, grind, or expose containers to heat, flame, sparks, or other sources of ignition. Empty drums should be completely drained, properly bunged and promptly returned to a drum reconditioner, or promptly disposed of.
