

# Husqvarna Professional Products, Inc. 2021 Newsletter Sign Up Sweepstakes Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND  
WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- 1. SPONSOR:** The sponsor of this sweepstakes is Husqvarna Professional Products, Inc. located at 9335 Harris Corners Parkway, Suite 500, Charlotte, North Carolina 28269 (the "**Sponsor**" or "**Husqvarna**").
- 2. ACCEPTANCE OF RULES:** By entering the **Husqvarna Professional Products, Inc. 2021 Newsletter Sign Up Sweepstakes** (the "**Sweepstakes**"), you (the "**Entrant**") hereby accept and agree to these official rules (the "**Rules**") of the Sweepstakes. Any violation of the Rules may result in disqualification.
- 3. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the United States who have reached the age of majority in their state of residence at time of entry. All officers, directors, employees, agents and representatives of Sponsor, any independent Sweepstakes judging organization, each of their respective parent corporations, subsidiaries, affiliates, sales representatives, distributors, licensees, prize providers, contractors or agents (all of the foregoing together with Sponsor, collectively, "**Sweepstakes Entities**"), and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether legally related or not), are ineligible to enter or win the Sweepstakes. - 4. SWEEPSTAKES PERIOD:** The Sweepstakes begins at 7:00:00 a.m. Eastern Time ("**ET**") on June 10, 2021 and ends at 11:59:59 p.m. ET on July 22, 2021 (the "**Sweepstakes Entry Period**"). Potential Winners (defined below) will be selected from Entries properly submitted to the Sweepstakes.
- 5. SWEEPSTAKES ENTRY INSTRUCTIONS:** NO PURCHASE NECESSARY. Internet access and valid email account required. Online entry through the Website (as defined below) only; no other means of submission will be accepted.

There is one (1) method of entry for this Sweepstakes: Sign up for our email newsletter. To enter during the Sweepstakes Entry Period, go to <https://www.husqvarna.com/us/discover/newsletter-sweepstakes/> ("**Website**") and sign up for the Sweepstakes by providing all of the required information to sign up for our newsletter ("**Entry**") OR fill out the pop-up form that will appear throughout the website ("**Website**") by providing all the required information ("**Entry**") to sign up for our newsletter. By submitting your Entry, you are indicating that you have read, understood and accepted these Official Rules.

Entries must be received within the Sweepstakes Entry Period to be eligible for the Sweepstakes. Entry must be submitted by the Entrant him or herself. Entrant may only use one (1) email address. LIMIT: one (1) Entry per person during the Sweepstakes Entry Period. Multiple Entries received from any one (1) Entrant beyond this limit will void all such additional Entries. Any Entrant found to be using multiple accounts to enter will be disqualified. Entries generated by a script, macro, or other automated means will be disqualified.

In case of a dispute over the identity of an Entrant, the authorized account holder of the email account associated with the Entry used to enter will be deemed to be the Entrant. "Authorized account holder" is defined as the person who is assigned to an email address by an Internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address. SELECTION OF SWEEPSTAKES WINNERS:** On or before Thursday, July 29, 2021 at 6:00PM ET ("**Sweepstakes Draw Date**"), three (3) entrants will be selected by a random draw from all eligible Entries received during the Sweepstakes Entry Period (each a "**Potential Winner**"). The odds of being selected as a Potential Winner are dependent upon the total number of eligible Entries received by the Sponsor during the Sweepstakes Entry Period. One Prize per Potential Winner.
- 7. PRIZE CLAIM CONDITIONS AND NOTIFICATION:** Sponsor will notify the Potential Winners by email within three (3) business days after the Sweepstakes Draw Date by 6:00 p.m. ET. The notification will contain instructions about responding, and the Potential Winner must respond by email within three (3) business days.
